**Confidential Information (Category I)**

Confidential information is classified as Category I information and requires a high degree of confidentiality, integrity, or availability.

This information is governed by law, contract, license, or other written agreements.

This information must be identified, documented, and protected.

**Proprietary Information (Category II)**

Proprietary information is classified as Category II information and includes information that is exclusive to the institution or has moderate requirements for confidentiality, integrity, or availability.

Proprietary information requires review by the Office of General Counsel prior to disclosure.

**Public Information (Category III)**

Public information is classified as Category III information and includes information with low requirements for confidentiality.

This information is intended for public release as described in the Texas Public Information Act. Public information requests must be submitted, reviewed, and approved by Office of General Counsel.

**Unit Head**

An individual with operational or executive authority over a business function.

**VP**

Vice President of a university within UNT System

**VC**

Vice Chancellor of a unit within UNT System Administration

**PII (Personally Identifiable Information)**

"Personal identifying information" means information that alone or in conjunction with other information identifies an individual, including an individual's:

- (A) name, social security number, date of birth, or government-issued identification number;
- (B) mother's maiden name;
- (C) unique biometric data, including the individual's fingerprint, voice print, and retina or iris image;
- (D) unique electronic identification number, address, or routing code; and
- (E) telecommunication access device as defined by Section 32.51, Penal Code.

- University assigned e-mail address
- University assigned Enterprise-wide User Identification Number (EUID)
- Month, day, and place of birth
- Major field of study
- Participation in officially recognized activities and sports
- Weight and height of members of athletic teams
- Dates of attendance
- Enrollment status (e.g., undergraduate or graduate; full time or part-time)
